The Hagerstown Housing Authority's Family Self-Sufficiency (FSS) Program offers employment and other case management services designed to promote economic self-sufficiency for families and individuals participating in the Housing Choice Voucher (HCV) and Public Housing (PH) Programs. The voluntary FSS Program assists participants to develop specific economic goals via their individual goal plan, and work with an FSS Coordinator to identify activities and services to help achieve these goals over a five-year period.

One of the benefits of the FSS program is an interest-bearing escrow account that is established by the Housing Authority in the name of each participating family. An escrow credit is based on increases in earned income that is credited to this account by the housing authority during the term of the FSS contract. Upon fulfillment of the five-year program and completion of the goals listed on the goal plan, families receive the funds in the escrow account.

FSS Coordinators are available to help families access a host of other career, training and community services as well. FSS program services may include, but are not limited to:

- Assistance in identifying and reaching goals within a specific time frame
- Referrals to community supportive services
- Informational and educational workshops
- Support and encouragement with the transition from government assistance to being financially independent
- Provide referrals to substance/alcohol abuse treatment or counseling
- Explore homeownership

## FROM MAINTENANCE



#### REMOVAL OF WINDOW AIR CONDITIONERS

At the beginning of heating season, as of October 1st all furnaces are turned on. During this change of season, the Authority requires all residents in family units to begin removing their air conditioners from windows. Air conditioners that have not been removed by November 1st, will be removed by maintenance and the resident will be charged. Your cooperation is greatly appreciated.

#### **HEATING SEASON**

Heating levels that will be maintained in the family communities are from 66 degrees to 68 degrees. Your thermostat has a built-in thermometer that will tell you if the proper heating levels are being maintained in your home. Before you call Maintenance for service on your heating system, take a minute to look at your thermostat. The bottom portion is the thermometer. If the temperature in your home is 66 degrees or above and you call for service, you will be charged for the call. Overtime callouts are very expensive, and you can avoid these charges (\$97.08) by checking the temperature before you call. Do not force the thermostat beyond the limit on the dial. Broken thermostats are charged to the resident. Keep your windows locked. This provides a much better seal & reduces air leakage at windows.

Remember, using your oven or stove as a source of heat is dangerous and a lease violation. This misuse not only poses a serious health risk to you and your family but will result in damage to your appliances for which you will be charged.

### **SNOW and ICE REMOVAL**

Residents are responsible to remove snow and ice from walks, steps and porches leading to the unit. This means all sidewalks to your unit with the exception of the front public sidewalk, which is the sidewalk that runs parallel to the front streets, is the responsibility of each resident. The Hagerstown Housing Authority does NOT remove snow and/or ice or treat for

snow and/or ice on any walkways in the rear of the units and do NOT remove snow and/or ice or treat for snow and/or ice in the front of your unit except for the public sidewalk that runs parallel to the front streets.

### My Friend has Bed bugs- Should I be worried??


Your friend is complaining about a bed bug infestation. You are concerned they could be brought into your home during one of their visits. Bed bugs easily travel inside of clothing, including coats, scarves and hats, purses, bags, backpacks, suitcases, & briefcases. They can also travel in shoes, electronics, stuffed toys, etc.

Avoid having your friend visit your home until the bed bugs are gone. If they do visit, place their belongings in a designated area, then inspect and vacuum that area once they are gone. Do not allow your friend into the bedroom when they visit and conduct a thorough visual inspection of the area when they are gone.

Have a conversation with your friend about the situation. Be kind and nonjudgmental, they are probably embarrassed about it. Explain to your friend that until their bedbugs are gone, you would prefer not to have them around. Instead, offer to meet at a public place.

Make sure you friend is doing everything they can to avoid spreading the bed bugs. For example:

- Laundering clothing and storing in sealed plastic bags far away from the bedroom area. Launder clothes on a regular basis.
- Before leaving the house, change into a "quarantined" set of clothes to avoid taking bed bugs with them.
- Routinely inspect common areas, such as the living room and bedroom. Remove and kill visible bedbugs.
- Let the professional do their job to get rid of the infestation.
- Bed bugs are very hard to get rid of without professional help.



### ATTENTION RESIDENTS OF NOLAND

The recycling bin located in front of the community building is to be used for recyclable items only. Should maintenance find bags of trash or other items placed on the ground and can identify where it came from, that resident will be charged.

4th Thursday: Frederick Manor




Please set your items out after 8:00pm the night before your scheduled day and have them on the curb prior to 8:30am on your scheduled pickup day. This schedule will be strictly followed. Any bulk items set on the curb on days other than those listed for your community will result in a charge (\$60.00) to the resident.

Scattered Site locations will be expected to observe the bulk pickup days published by the City of Hagerstown. Check the newspaper or call the City for dates.

\*Due to the Thanksgiving Holiday normal Thursday and Friday trash collections will be delayed one day.
