## Important Reminder

This is the last month for C.W.Brooks, Parkside Homes, Douglass Court, and Gateway Crossing to receive a paper rent statement. Please watch for training this month in your community.

## **Paperless Rent Statements**


We are now finalizing the process for paperless rent statements. Here's what you can expect:

- You will be provided a **"Coupon Book"** consisting of 12 cards (one for each month). The cards will include your name, address, community, and **WIPS** (Walk-In Payment System) number.
- If you PAY AT THE BANK provide the card to the teller and pay the amount you choose.
- **If you pay your rent by MAIL** or **DROPBOX** instead of a rent statement, you will include a card with your payment.
- If you pay your rent via Tenant Portal you do not need anything further.
- The 12 cards will be provided to you at your recertification, annually.

We will implement the paperless statements based on the following schedule:

**June 1st** - C.W.Brooks, Parkside Homes, Douglass Court, and Gateway Crossing will no longer receive rent statements.

**August 1st** - Noland Village, Frederick Manor, Potomac Towers, Walnut Towers, McCleary Hill, and Scattered Sites.

# **Diabetes Prevention Program**

Meritus Health has been awarded a grant to prevent diabetes in our county. The goal is to offer this program throughout the community to whoever is interested and meets the eligibility requirements.

## Who is eligible?

To be eligible you must:

- Be at least 18 years old AND
- Be overweight (Body Mass Index ≥25; ≥23 if Asian) AND
- Not be pregnant AND
- Have no previous diagnosis of type 1 or type 2 diabetes AND
- Have a blood test result in the prediabetes range within the past year:

Hemoglobin A1C: 5.7-6.4% or


Fasting plasma glucose: 100-125 mg/dL or

Two-hour plasma glucose (after a 75 gm glucose load): 140–199 mg/dL OR

- · Have a previous clinical diagnosis of gestational diabetes OR
- Have a positive risk test

Note: Medicare beneficiaries require a blood test, clinically administered within the last year, to qualify for eligibility; self-reporting is not allowed for Medicare beneficiaries

#### **Trash Containers**

Effective April 1, 2022, all trash cans and toters must be placed and kept in the rear of your unit. Containers must be moved after they are emptied on the day of pick up to avoid a charge. You will be charged a minimum of \$32.36 if maintenance has to move your container to the rear of your unit. As always, we appreciate your help in keeping our communities beautiful. *Trash containers are not to be placed out before 4:00 pm on trash pick-up night at your community.*

#### "Bed Bugs Bite, Ouch"

Yes it is true; bed bugs do bite and feed on blood. Bed bugs are a smaller insect and sometimes are considered a "lazy bug". Considering their nature because they live close t their food supply and they may bite many times trying to find the easiest spot to pierce the skin to access a blood meal. Also, they will hide very close to where humans sleep or rest to have easy access to their food supply as they do not like to travel far. Bed bugs are found hiding in beds, blankets, counches, chairs, dressers, and even clothes that are in close proximity to where humans sleep.

Bed bugs will try and find a delicate area to bite on the human body such as the face, neck, arms, ankles or easy open areas with exposed skin. Most of the biting occurs at night when we are very still with no movement and the bed bugs feel safe to come out of hiding. The ares bitten are small and sometimes you will see raised bumps on the skin. The other most common signs of bed bug bites include the redness around the very tiny punture and some swelling associated with the affected site. Not everyone's skin will react in the same manner and many people report different allergic reactions to the bite. Bed bug bites may go unnoticed right away and mistaken for flea or mosquito bites because the skin reations are very similar.

Remember if you are getting bit inside your unit or think you may have bed bugs please call the maintenance department right away at 301-733-6911 ext. 132. We have a full time Pest Control Coordinator that will set up a free inspection of your unit for bed bugs and the coordinator along with the pest control contractor will assist you with how the treatment process works and the procedures to follow. The service is free of charge so please take advantage of it and let the professionals take care fo the unwanted insects in your home.

## **Reminder For Family Communities**

No items are allowed to be chained to, locked to, or stored on or against the gas pipes. BBQ grills must be kept at least 5 feet away from any gas pipes. All other items, such as bicycles, kid's toys, etc., must be at least 3 feet away from gas pipes. Failure to follow these rules could result in a citation and Maintenance removing the items at the cost of the resident.

#### **Lockouts**

Please note that there are no charges for lockouts during regular business hours, 8:00 am to 4:30 pm Monday thru Friday. The Security Supervisor will handle lockouts after regular business hours at no charge only when available. If the Security Supervisor is not available, it will be necessary for a Maintenance Mechanic to respond. Avoid receiving an overtime lockout charge by making sure you always have your key with you before locking your door or have access to a spare key. The current overtime charge is \$97.08.

# INFORMATION FROM SECURITY

As a reminder Fireworks of any kind are prohibited on all HHA properties and is considered a violation of the lease. Fireworks Dwelling lease Part II Table of Contents, Section G Tenants Obligations- Tenant Shall be obligated: Page 11, Rule 14: Not to keep or maintain, manufacture, or distribute fireworks or other explosive material or to discharge fireworks on or near the premises. Any tenant or guest violating this provision may be subject to a lease infraction notice.
