Looking back

As we go into the new year, it's a perfect time to pause and reflect on the progress we've made, the challenges we've overcome, and the opportunities that lie ahead. Together, we've accomplished so much, and we are excited about what we can achieve in the year to come.

Hagerstown Housing Authority (HHA) was once again recognized as a High Performing agency under HUD's Public Housing Assessment System and Section 8 Management Assessment Program. HHA currently manages 1,337 affordable housing units and provides subsidies for another 943, totaling 2,280 units – demonstrating excellence in housing operations and compliance.

The Family Self-Sufficiency (FSS) Program, administered through the Resident Services Department, provides voluntary, individualized case management for Public Housing and Housing Choice Voucher participants. Designed to help families achieve long-term financial stability, the program offers up to five years of structured support through a collaborative contract with a dedicated FSS Coordinator. In the past year, HHA celebrated the graduation of 20 participants who successfully completed their goals, earning escrow payouts ranging from \$2,198 to \$38,463.01. These graduates achieved a variety of meaningful milestones, including improving credit scores, reducing debt, enhancing English language proficiency, earning job promotions, completing training and educational programs, and becoming first-time homebuyers.

Today, the FSS Program serves 129 active participants, with continued growth anticipated as more families engage in goal development, financial coaching, and supportive services. The program's measurable outcomes highlight its powerful community impact, showing that families leave with increased savings, stronger financial health, more stable employment, and greater opportunities that contribute to lasting self-sufficiency.

HEATING SEASON

Heating levels that will be maintained in the family communities are from 66 degrees to 68 degrees. Your thermostat has a built-in thermometer that will tell you if the proper heating levels are being maintained in your home. Before you call Maintenance for service on your heating system, take a minute to look at your thermostat. The bottom portion is the thermometer. If the temperature in your home is 66 degrees or above and you call for service, you will be charged for the call. Overtime callouts are extremely expensive, and you can avoid these charges (\$103.44) by checking the temperature before you call. Do not force the thermostat beyond the limit on the dial. Broken thermostats are charged to the resident. Keep your windows locked. This provides a much better seal & reduces air leakage at windows.

Remember, using your oven or stove as a source of heat is dangerous and a lease violation. The misuse not only poses a serious health risk to you and your family but will result in damage to your appliance for which you will be charged.

BULK TRASH PICKUP SCHEDULE

You may have your bulk items picked up on the following days of each month:

- 1st Thursday: McCleary Hill
- 2nd Thursday: Parkside Homes and Douglass Court
- 3rd Thursday: Noland Village
- 4th Thursday: Frederick Manor ***due to the Holiday this week, bulk will be picked up on Friday, January 2, 2026**

Please set your items out after 8:00 pm the night before your scheduled day and have them on the curb prior to 8:30 am on your scheduled pickup day. This schedule will be strictly followed. Any bulk items set on the curb on days other than those listed for your community will result in a charge (\$60.00) to the resident.

Scattered Site locations will be expected to observe the bulk pickup days published by the City of Hagerstown. Check the newspaper or call the City for dates.

***Please note: Due to the Christmas Holiday (Thursday, December 25) trash collections on Thursday and Friday this week will be delayed one day.**

SNOW & ICE REMOVAL

A major concern during winter is the clearing of ice and snow. Residents in the family communities are responsible for promptly clearing ice and snow from the front and rear sidewalks leading to their units. Residents who fail to promptly clear their walks will be charged when the Maintenance Department must perform the work. The maintenance crews get to the public walks as soon as possible.

The Hagerstown Housing Authority does NOT remove snow and/or ice or treat for snow and/or ice on any walkways in the rear of the units, and does NOT remove snow and/or ice or treat for snow and/or ice in the front of your unit except for the public sidewalk that runs parallel to the front streets.

“Residents are responsible for removing snow and ice from walks, steps, and porches leading to the unit. Residents sharing a walk shall clear their half or share the responsibility”.

Ice scrapers are a much cheaper method of removing ice from walks than chemicals are. In addition, the extensive use of chemicals such as salt may damage the concrete making repairs necessary. Salt will damage next spring's grass and flowers as the melting ice carries it to the root systems. If you must use salt, clean it up once it has done its' job.

Residents should exercise good judgment in placing the snow that they remove from the walks. Never throw it out into the streets or courts. Never place it where your neighbors or the Maintenance Department will have to move it again. Please do not allow your children to cover up cleared walks.

The better you fulfill your responsibilities, the better we will be able to perform ours.

HOLIDAY DECORATIONS

Now that the holidays are over, please remove your decorations prior to the end of January. Any tape, tacks or nails used to mount lights need to be removed as well as spray snow on windows. Remember never to run electrical cords through closed windows or doors. This pinches the cord and can cause a fire.

The Authority appreciates your cooperation in maintaining the appearance of our communities.

If the detector “beeps” frequently this could indicate the need for a new battery. Call the Maintenance Department at 301-733-6916. Any other smoke detector problem is also a job for maintenance.

Funding was secured in 2025 to complete the final phase of the Noland Village redevelopment. The remaining 116 barrack-style units built in 1972 will undergo substantial rehabilitation. The new development will be rebranded as “Martin Heights” and is anticipated to close the first quarter of 2026 with construction beginning shortly after. The new development will consist of modern kitchens and bathrooms (with 1st-floor powder rooms), in-home laundry hookups, central air & heat, energy-efficient appliances, handicap-accessible redesign, accommodations for visual/hearing impairments, upgraded parking, landscaping, new playgrounds, and a new community building.

The Hagerstown Housing Authority (HHA), in partnership with the City of Hagerstown, was awarded a \$500,000 Choice Neighborhoods Planning Grant by the U.S. Department of Housing and Urban Development (HUD) in Fall 2023. Among 28 applicants nationwide, Hagerstown was selected as one of 14 grantees to lead a comprehensive community revitalization effort.

The Choice Neighborhoods Initiative (CNI) by HUD is designed to revitalize distressed public housing and transform surrounding neighborhoods into mixed-income, vibrant communities. Key goals include improving housing, investing in residents, and strengthening community infrastructure. The two-year grant (Oct 2023–Oct 2025) aims to develop a Transformation Plan with deep community input. Key target areas include public housing sites: Douglass Court, Parkside Homes, and Frederick Manor, alongside surrounding neighborhoods and downtown Hagerstown.

The robust, two-year planning effort included: needs assessment surveys of residents and businesses, workshops and forums to gather feedback on childcare, workforce development, transportation, and more, formation of a Housing Task Force and People & Neighborhood Task Force, drawing stakeholders from HHA, local nonprofits, schools, health services, police, business groups, and faith-based organizations. This transformative initiative plans to replace outdated public housing with safe, mixed-income residential environments, strengthen social infrastructure, healthcare, education, transit, and services, and elevate community vitality through beautification, business partnerships, and public safety investments. The final plan was submitted to HUD in September of 2025 and can be found on our website at www.hagerstownha.com/choice-neighborhoods/.

In 2026, the Authority will finalize its strategic plan and shift to active project implementation / launching mixed-income developments and complementary social infrastructure. Continued engagement with residents, HUD, City of Hagerstown, and state partners will drive the success of the Choice Neighborhoods initiative and transformative community investment.

We would like to thank our dedicated staff, residents, and partners for their time, insight, and collaboration. Your contributions have been essential in laying out the groundwork for systemic, positive change in Hagerstown.

CABLE TRIPPERS

If you have TV or telephone cable crossing stairs or walkways, please remove them immediately. Per your lease agreement, cables are not permitted to be run in a manner that may cause a tripping hazard. Cables are to be fastened to the baseboard and door frames by use of cable tacks ("U" shaped tacks). Cables are to be run up and around door frames and NOT across walkways. If you could trip over it, then it is improperly installed. Improperly installed cable will be removed by maintenance and the cost charged to the tenant. New or existing cable will not be re-installed causing you the loss of use of the TV or telephone served by the cable. Avoid this major inconvenience by properly installing your cable now.
